### **Retiree Benefits Program – Deadline to Apply for \$500 Payment is Nov. 30**

Eligible members of the Nurses' Bargaining Association (NBA) Retiree Benefit Program (RBP) are entitled to a one-time payment of \$500. These members must have retired on or before Dec. 31, 2022 and be enrolled in the RBP.

**The deadline to enrol in the RBT and apply for the payment is Nov. 30, 2023.** Members who retired on or after Jan. 1, 2023 are not eligible.

### **Flu and COVID Vaccinations Now Available**

Following Thanksgiving, the province invited eligible individuals to book an appointment for updated influenza and COVID-19 vaccines. Invitations include a direct link to book an appointment online. If you have previously received a COVID-19 vaccine in BC, then you are registered in the province's Get Vaccinated system. Invitations were sent to priority populations first, including those 65 or older, long-term care residents, Indigenous Peoples, those with

chronic health conditions, and health-care workers.
